
As per reports received from the Director General Of Civil Defence & Commandant General of Home Guards, Assam, Beltola, Guwahti-28, a total 2519 applications were received for recruitment for LDA (Grade-III) -3 posts & Storeman (Grade-III) -2 posts in the Central Training Institute (Civil Defence & Home Guards) Panikhaiti, Guwahati-26 in pursuance to Advertisement No. CG.35/2006/PT-I/26 dated 13-11-2015. Out of 2519 applications only 387 applications were found valid and 2132 applications were invalid and rejected for various reasons.

Similarly, a total 832 applications were received for recruitment for Jr. Assistant (LDA)-2 posts of Directorate of Civil Defence & Home Guards, Beltola, Guwahati-28 in pursuance to Advertisement No. CG.56/08/194 dated 31-10-2015. Out of 832 applications only 127 applications were found valid and 705 applications were invalid and rejected for various reasons.
